State below in reasonable detail why Forms 10-K, 20-F, 11-K, 10-Q, 10-D, N-SAR, N-CSR, or the transition report or portion thereof, could not be filed within the prescribed time period.

As first disclosed in the press release dated February 20, 2018, which the Company also furnished on Form 8-K on such date, MiMedx Group, Inc. (the "Company") has not been able to timely file its Form 10-K for the year ended December 31, 2017. The Audit Committee of the Company's Board of Directors engaged independent legal and accounting advisors to conduct an internal investigation into current and prior-period matters concerning sales and distribution practices and other matters.

As disclosed in the press release dated November 7, 2018, which the Company also furnished on Form 8-K on such date, the Company indicated that it is assessing revenue recognition for all of the Company's sales since January 1, 2012. The Company will not be in a position to file its Form 10-K for the year ended December 31, 2017 or the year ended December 31, 2018, or any Forms 10-Q for quarters ending after December 31, 2017 until the conclusion of the Audit Committee's internal investigation and the finalization of the Company's review of the accounting and assessment of revenue recognition for sales since January 1, 2012.

In its definitive proxy statement filed May 31, 2019, the Company disclosed a summary of the findings of the Audit Committee investigation.

The Company has initiated the finalization of its review of the accounting and assessment of revenue recognition for sales since January 1, 2012 and is working with its independent registered public accounting firm in connection with the audits of its financial statements.
